

The Man of Lawlessness Revealed! Constantine the Great

“And he will speak out against the Most High and ... make alterations in [God’s appointed] times and in [the Mosaic] law ... (Daniel 7:25).”

The man who did precisely this was the Roman Emperor Constantine, who did away with God’s appointed times — the Biblical Holy Days — and instituted pagan holidays in their place.
